The Government of Himachal Pradesh (GoHP) has applied for financing from the World Bank towards the cost of the Himachal Pradesh State Roads Transformation Project (HPSRTP), and intend to apply part of the proceeds for 'Procurement of Safety assessment of major road network in H.P. using iRAP methodology with the objective to enhance the efficiency of the transportation and Road Safety institutions and develop efficient logistics system for horticulture and overall economic growth in Himachal Pradesh.

The Himachal Pradesh Roads and Infrastructure Development Corporation Limited (HPRIDCL) now invite eligible consulting firms ("Consultants"), to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are given in the Expression of Interest (EoI). The EoI includes the following documents:

Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the QCBS method set out in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 and its latest revision ("Procurement Regulations").

1.	Consultant shall go through the guidelines given below and section II before preparing EoI proposal.
2.	Consultant who meets short listing criteria given in section II, shall prepare EoI as per the guidelines. If the Consultant feels to submit certain information not covered in the guidelines would be in his interest, he may submit such information
3.	Accomplished Expression of Interest (Application) must be submitted together with a Letter of Intent not later than <b>15:00 hours (IST) on 21-01-2022.</b> Documents in support of all qualification information shall be submitted with application. Proposal of EoI with qualification information shall be furnished on/before the due date of submission at the address shown under Para 12 here below.
4.	The Section-II shall be basis of drawing up a shortlist of eligible consultants who will be invited to submit proposal for services required.
5.	All Applications shall be submitted in English.
6.	Power of attorney (on stamp paper duly notarized) of the person submitting the Expression of Interest on behalf of the Applicant shall be attached. Joint Venture (JV) shall not have more than 2 members. One of the members should be a Lead Member.
7.	The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture member in another Proposal, if a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected.
8.	The Application and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by Applicant with the Application may be in any other language provided that they are accompanied with translations in the English language. 	Following information shall be submitted using given formats and where no formats are specified, free format can be used.
1.	Complete name of firm, date of establishment and type of organization whether individual, proprietorship, partnership, private limited company, public limited company etc. ( <b>Annexure I</b> ).
2.	Exact and complete corporate/registered/home office address, business address, telephone numbers, fax numbers, E-mail and cable address. For consultant of foreign registry, indicate if there is any branch office(s) established in India with details in aforesaid manner. Information is to be furnished by sole applicant or members of JV individually ( <b>Annexure I</b> ).
3. #### **Section - II**

#### **Short Listing Criteria**

#### A. Annual Turn Over

- (i) Average Annual turnover of the last five financial years i.e. from 2016-17 to 2020-21 updated to the current financial year shall be more than Rs. 5 crores in case of single entity. In case of JV, the lead member shall have more than Rs. 3 crores of average annual turn-over (updated) of the last five financial years. This threshold for other member of JV shall be more than Rs. 2 crores.
- (ii) For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement/updating factor corresponding to that year given in the **Annexure-II**.

#### B. Experience

Consultant must have experience as follows:

- a) Consultant firm (Lead/ JV partner) should have at least 5 years' experience in road asset data collection/ road safety audit/iRAP assessment with cumulative contract amount not less than Rs. 1 Crore.
- b) Consultant firm (Lead or JV partner) should have completed a minimum one similar assignment (iRAP surveys and star rating assessment) in the last 5 years with contract amount not less than Rs. 25 Lakhs each.
- c) The key professionals (as required in the ToR) of the Consultant firm (Lead or JV partner) must have iRAP Accreditation (as per the ToR) along with prior experience of handling iRAP project(s).
