**NOTIFICATION**

In exercise of the powers conferred by Rule-6 of the Scheduled Tribes and Other Traditional Forest Dwellers(Recognition of Forest Rights) Rules,2007, the Governor, Himachal Pradesh is pleased to re-constitute the Distt. Level Committee in respect of Distt. Una for implementation of the provisions of the said rules. Each Committee shall consist the following members:-

1.	Deputy Commissioner	Chairman
2.	Divisional Forest officer or concerned Deputy Conservator of Forest	Member
3.	Shri Raj Kumar VPO Dhmandri, Teh. & Distt Una(H.P)	Member
4.	Smt. Indu Bala, Vill.Naili , PO & Tehsil Bangana , Distt. Una (H.P)	Member
5.	Sh. Ramesh Chand , VPO Gagret, Tehsil Amb, Distt. Una (H.P)	Member
6.	ADC/ADM of the Distt.	Member Secretary.

**Functions of the above committee shall be as under:-**

**The District Level Committee shall :**

- (a) Ensure that the requisite information under cause (b) of rule 6 has been provided to Gram Sabha or Forest Right Committee.
- (b) Examine whether all claim, especially those of primitive tribal groups, pastoralists and nomadic tribes, have been addressed keeping in mind the objectives of the ACT.
- (c) Consider and finally approve the claims and record of forest right prepared by the Sub- Divisional Level Committee;

- (d) Hear petitions from person aggrieved by the orders of the Sub-Divisional Level Committee ;
- (e) Co-ordinate with other districts regarding inter-district claims;
- (f) Issue directions for incorporation of the forest rights in the relevant government records including record of right;
- (g) Ensure publication of the record of the forest right as may be finalized; and
- (h) Ensure that a certified copy of the record of forest rights and title under the Act, as specified in Annexures II&III to these rules, is provided to the concerned claimant and the Gram Sabha respectively .

T.A and D.A. will be admissible to the Members of the above Committee as per the Government norms/rules amended from time to time.


