**NOTIFICATION**

In exercise of the powers conferred by Rule-7 of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Rules, 200, the Governor, Himachal Pradesh is pleased to constitute the Divisional Level Committee, in respect of Urban Areas of Kullu, District Kullu for implementation of the provisions of the said rules. The Committee shall consist the following members:-

**Functions of the above Committee shall be as under :-**

**The District Level Committee shall :**

- Ensure that the requisite information under clause (b) of rule 6 has been provided to Gram Sabha or Forest Right Committee;
- Examine whether all claims, especially those of primitive tribal groups, pastoralists and nomadic tribes, have been addressed keeping in mind the objectives of the Act;
- Consider and finally approve the claims and record of forest rights prepared by the Sub-Divisional Level committee;
- Hear petitions from persons aggrieved by the orders of the Sub-Divisional Level Committee;
- Co-ordinate with other districts regarding inter-district Claims;
- Issue directions for incorporation of the forest rights in the relevant government records including record of rights;
- Ensure publication of the record of forest rights as may be finalized; and
- Ensure that a certified copy of the record of forest rights and title under the Act, as specified in Annexures II&III to these rules, is provided to the concerned claimant and the Gram Sabha respectively.
- Ensure that a certified copy of the record of the right to community forest resource and title under the Act, as specified in Annexure IV to

these rules, is provided to the concerned Gram Sabha or the community whose rights over community forest resource have been recognized under clause (i) of sub-section (1) of Section 3.

T.A& D.A. will be admissible to the members of the above Committee as per the Government norms/rules amended from time to time.
