At the outset of the meeting Commr.-cum-Pr. Secy. (TD) welcomed all the participants. Thereafter, following item was discussed in the meeting and decision taken shown below against the item:

1. Regarding Petition received from Gram Panchayat Dhamchayan, Tehsil Padhar, District Mandi under Section – 8 of Forest Rights Act, 2006.

The committee examined the notice given by the Gram Panchayat Dhamchayan, Tehsil Padhar, District Mandi and the reply furnished by the Deputy Commissioner, Mandi in this regard. Deputy Commissioner, Mandi apprised that whole process has been followed as per the provisions of the Act/ Rules while settling the rights of concerned Panchayat. During the process nil claims were received in Gram Sabha after proclamation was made and the same was accepted by the Gram Sabha, Sub Divisional Level Committee & District Level Committee and recorded in the proceedings of District Level Committee meeting. On the basis of process followed as per the provisions of Act/ Rules, FRA certificate was issued in favour of Jal Shakti Vibhag.

Decision taken:

In view of reply given & position explained by Deputy Commissioner, Mandi, the Committee decided that no penal action is called for.

The meeting ended with a vote of thanks to and from the chair.
