At the outset of the meeting Additional Commissioner-cum-Spl. Secy. (Tribal Development) welcomed all the participants. Thereafter, following item was discussed in the meeting and decision taken shown below against the item:

1. Regarding Petition received from Gram Panchayat Murhag, Tehsil Thunag, District Mandi under Section – 8 of Forest Rights Act, 2006.

The committee examined the notice given by the Gram Panchayat Murhag, District Mandi and the reply furnished by the Deputy Commissioner, Mandi in this regard. Deputy Commissioner, Mandi apprised that whole process has been followed as per the provisions of the Act/ Rules while settling the rights of concerned Panchayat/ issuance of NOC. During the process nil claims were received in Gram Sabha after proclamation was made and the same was accepted by the Gram Sabha, Sub Divisional Level Committee & District Level Committee. The case was discussed in detail and view of official as well as non-official members were sought and on the basis of decision taken in DLC meeting, FRA certificate was issued in favour of M/s Micro Hydro Electric Power Generation (P) Ltd..

Decision taken:

In view of reply given & position explained by Deputy Commissioner, Mandi, the Committee sought the detailed information along with record from him regarding the process followed and IEC provided under FRA in the concerned Gram Sabha on priority to decide the petition in the next State Level Monitoring Committee meeting.

The meeting ended with a vote of thanks to and from the chair.
