PROCEEDING OF THE MEETING OF STATE LEVEL MONITORING COMMITTEE HELD UNDER THE CHAIRMANSHIP OF CHIEF SECRETARY (ALSO INCHARGE TRIBAL DEVELOPMENT AND COMMISSIONER, TRIBAL DEVELOPMENT) ON 25-7-2017 AT 4:00 P.M. TO MONITOR THE PROGRESS UNDER FOREST RIGHTS ACT, 2006

It was apprised that State, Divisional and District Level training programmes have already been organised for officers of Revenue, Forest, Rural Development & Panchayati Raj and other departments as well as elected representatives of PRIs for which adequate funding was also provided. It was informed that 17503 FRCs, 76 SDLCs and 19 DLCs have been constituted. 7 (ST) Community titles and 53 (OTFD) Individual titles over land measuring 1890.11 Hectare and 0.4289 Hectare respectively have been recognized and vested. After detailed discussion, the following decisions were taken:-

1. It was decided that training programmes imparted to official and elected representatives have proved very fruitful as these have created awareness about FRA throughout the State. It was decided that more training programmes for officers of Revenue, Forests, Rural Development & Panchayati Raj departments and other departments may be organized at State and Divisional level in collaboration with UNDP, HIPA and District Administration, as the case may be.
2. It was discussed that community rights in Himachal Pradesh have already been defined in Record of Rights. It was decided that even if not many individual claims are being received, the Deputy Commissioners must create awareness and make all efforts to finalize the community rights as it shouldn't be difficult to settle them expeditiously, for they are well defined in the Record of Rights also.

The meeting ended with a vote of thanks to and from the chair.
