### Request for Quotation (RFQ)

1. This RFQ is for the procurement of Accessories and its Fabrication work for Patrol Motorcycles to support annual enforcement program of HP police in Kangra and Mandi district.
2. The Government of Himachal Pradesh through the Government of India (hereinafter called "Borrower") has received financing from the World Bank (the "Bank") in the form of a "loan" (hereinafter called "loan") toward the cost of Himachal Pradesh State Roads Transformation Project. The Himachal Pradesh Road and Infrastructure Development Corporation Limited (HPRIDCL), an implementing agency of the Client, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for which this Request for Quotation (RFQ) is issued.
3. The HPRIDCL now invites quotations from eligible Fabricators/ Suppliers for the **accessories and fabrication work of Patrol Motorcycles** described in Annex 1: Purchaser's Requirements, attached to this RFQ.

### Fraud and Corruption

4. The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in the attachment to the Contract Conditions (Attachment A).
5. In further pursuance of this policy, Suppliers shall permit and shall cause their agents (where declared or not), subcontractors, sub-consultants, service providers, suppliers, and personnel, to permit the Bank to inspect all accounts, records and other documents relating to the RFQ and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

### Eligible Goods (*and Related Services if applicable*)

6. All the Goods and related Services to be supplied under the Contract and financed by the Bank may have their origin in any country in accordance with Para. 10.

## Eligible Suppliers

7. In case the Supplier is a joint venture (JV), all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate a representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Request for Quotations process and, in the event the JV is awarded the Contract, during contract execution.
  8. A Supplier may have the nationality of any country, subject to the restrictions pursuant to para. 9 and 10 hereinafter. A Supplier shall be deemed to have the nationality of a country if the Supplier is constituted, incorporated or registered in, and operates in conformity with, the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the determination of the nationality of proposed subcontractors or sub-consultants for any part of the Contract including Related Services.
  9. Firms and individuals may be ineligible if so indicated in para. 10 below and:
    - (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of Goods or the contracting of works or services required; or
    - (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of Goods or contracting of works or services from that country, or any payments to any country, person, or entity in that country.
  10. In reference to paras. 6 and 8, for the information of suppliers, at the present time firms, goods and services from the following countries are excluded from this procurement process:
    - (a) Under para. 6 and 9 (a): *None*
    - (b) Under para. 6 and 9(b): *None*
  11. A Supplier that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines, in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in the attachment to the Contract Conditions (Attachment A) paragraph 2.2 d., shall be ineligible to submit Quotations or be awarded or otherwise benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. A list of debarred firms and individuals is available on the Bank's external website: <http://www.worldbank.org/debarr>.
  12. Suppliers that are state-owned enterprises or institutions in the Purchaser's country may be eligible to compete and be awarded a Contract(s) only if they can establish, in a manner acceptable to the Bank, that they:
    - (a) are legally and financially autonomous;
    - (b) operate under commercial law; and

(c) are not under supervision of the Purchaser.

13 Bidders Capacity & Experience

- a. Suppliers or Vendors with valid registration and license under relevant statutes and having 3 years of experience in dealing with fabrication work including custom fit additions and accessories of fully functional Vehicles for Police or any other relevant authority in any states in India.
- b. Should have an annual turnover of INR 12 Lakhs or more in any of last three financial years and shall submit audited balance sheet for the same.
- c. Added advantage for completion of similar work and supply of Patrol Motorcycles to any regulatory agencies in India.

In case of bidders who form a JV with vendor/fabricator for bidding shall confirm the qualifications mentioned above in (a) and (b)

14. A Supplier shall not have a conflict of interest. Any Supplier found to have a conflict of interest shall be disqualified. A Supplier may be considered to have a conflict of interest for the purpose of this Request for Quotations process, if the Supplier:
  - (a) directly or indirectly controls, is controlled by or is under common control with another Supplier that submitted a Quotation;
  - (b) receives or has received any direct or indirect subsidy from another Supplier that submitted a Quotation;
  - (c) has the same legal representative as another Supplier that submitted a Quotation;
  - (d) has a relationship with another Supplier that submitted a Quotation, directly or through common third parties, that puts it in a position to influence the Quotation of another Supplier, or influence the decisions of the Purchaser regarding this Request for Quotations process; or
  - (e) or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the Goods, or Related Services, that are the subject of the Request for Quotations process; or
  - (f) or any of its affiliates has been hired (or is proposed to be hired) by the Purchaser or Borrower for implementing the Contract; or
  - (g) would be providing Goods, works, or non-consulting services resulting from, or directly related to consulting services for the preparation or implementation of the project specified in this Request for Quotations, that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or
  - (h) has a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who:
    - (i) are directly or indirectly involved in the preparation of the Request for Quotations or specifications and/or the evaluation of Quotations, of the subject Contract; or
    - (ii) would be involved in the implementation or supervision of such Contract unless the conflict stemming from such relationship has been resolved in

a manner acceptable to the Bank throughout the Request for Quotations process and execution of the Contract.

### **Performance Security**

### **Manufacturer's Authorization**

16. A Supplier that does not manufacture or produce the Goods it offers to supply shall submit a Manufacturer's Authorization using the form included to this RFQ to demonstrate that it has been duly authorized by the manufacturer or producer of the Goods to supply these Goods in the Purchaser's Country.

### **Validity of offers**

17. The offers shall be valid until **120 days** from the issue of this RFQ.

### **Quoted Price**

18. Prices shall be quoted in the following manner:

(a) For Goods to be supplied from within the Purchaser's Country:

- (i) the price of the Goods quoted EXW, including all customs duties and sales and other taxes already paid or payable on the components and raw material used in the manufacture or assembly of the Goods;
- (ii) if known, any Purchaser's Country sales tax and other taxes which will be payable on the Goods if the Contract is awarded to the Supplier; and
- (iii) the price for inland transportation, insurance, and other local services required to convey the Goods to their final destination (Project Site) shall be at O/o Director (Projects), HPRIDCL, Nirman Bhawan, Nigam Vihar, Shimla-171002, Himachal Pradesh.

(b) Deleted.

(c) for Related Services, other than inland transportation and other services required to convey the Goods to their final destination, **whenever such Related Services are specified in the Schedule of Requirements**, the price of each item comprising the Related Services (inclusive of any applicable taxes).

### **Submission of Quotations**

21. Quotations are to be submitted in the form attached at Annex 2 and before the submission deadline, either by registered post/speed post/courier or by hand, failing which the quotations will be declared non-responsive and will not be opened. The Purchaser requires 3 copies of the same quotations to facilitate the procurement process.

### **Opening of Quotations**

24. Quotations will be opened by the Purchaser's representatives immediately after the deadline for the submission of Quotations in presence of bidders or authorized representatives who wish to remain present.

### **Evaluation of Quotations**

25. Quotations will be evaluated to ensure compliance with the Technical Specifications, Delivery and Completion Schedules and any other requirements of the RFQ.
26. The comparison shall be on the basis of CIP (place of final destination) prices for Goods to be supplied from outside the Purchaser's country and EXW prices plus cost of inland transportation and insurance to place of destination, for Goods supplied from within the Borrower's country; together with prices for any required installation, training, commissioning and other services. The evaluation of prices shall not take into account custom duties and other taxes levied on imported goods quoted CIP and sales and similar taxes levied in connection with the sale or delivery of goods.

28. The lowest evaluated price will be determined after correcting any arithmetic errors and other specified adjustments, if any.
29. Quotations will be evaluated for each item and the Contract will comprise the item(s) awarded to the successful Supplier.

### **Contract Award**

31. The Contract will be awarded to the Supplier/s who:
-

- (a) is eligible and offers eligible Goods;
  - (b) offers the lowest evaluated price/s,
  - (c) technically compliant quotation, and
  - (d) guarantees delivery, in accordance with the delivery period/s.
32. The Purchaser shall invite by the quickest means [*e.g. e-mail*] the successful Supplier/s for any discussion/ negotiation that may be needed to conclude the contract or otherwise for contract signature.
33. The Purchaser shall communicate by the quickest means with the other Suppliers on its contract award decision. An unsuccessful supplier may request clarifications as to why its quotation was not determined to be successful. The Purchaser will address this request within a reasonable time.
34. The purchaser shall award the contract for fabrication to the successful supplier only after ensuring the delivery of Motorcycles on site mandated by the O/o ASP, Traffic, Tourist & Railways (TTR), New Police Complex, Shimla-171002
14. The Purchaser shall publish a contract award notice on its website with free access, if available, or in a newspaper of national circulation or UNDB online, within 15 days after award of contract. The information shall include the name of the successful Supplier, the Contract Price, the Contract duration, summary of its scope and the names of the Suppliers and their quoted and evaluated prices.

## 1.2 Technical Specifications

### Objective

HPRIDCL is endeavouring to improve Road Safety Enforcement interventions, rescue and emergency services for enhancing safety of road users by assisting the Police in the state and intends to provide them with necessary equipment, applications and systems.

In order to fulfill the requirements of enhancing traffic safety enforcement, HPRIDCL intends procurement of accessories and fabrication of fully functional patrol motorcycles to support Annual Enforcement Program of HP Police and supply the equipment to the Shimla and Nurpur Police districts through TTR division of HP Police.

### Purpose

The purpose is to procure accessories and conduct fabrication of patrol motorcycles and supply through Traffic, Tourist & Railways division of HP Police to distribute to Shimla district along with Nurpur Police District.

The successful Bidder must make sure that the technical and functional specifications given below must be met or provide equipment of a better version than mentioned in this document. All the items shall be properly fitted and integrated into the Patrol Motorcycle in such a way that ensures the safe use of motorcycles.

- Delivery to be done at O/oASP, Traffic, Tourist & Railways (TTR), New Police Complex, Khalini, Shimla-171002, Himachal Pradesh.

**(b) Fabrication of Accessories**

- All the accessories or add-ons mentioned shall be fitted and integrated to the motorcycles for seamless operation and safe use. The fabrication work shall be conducted at the site mandated by the O/o AIG, Traffic, Tourist & Railways (TTR), New Police Complex, Khalini, Shimla-171002, Himachal Pradesh.
- The bidder is responsible for the up-keeping and safety of the vehicles during fabrication until the final delivery.

**(c) Warranty**

- Standard Manufacturer's commercial Warranty/Guarantee for 24 months shall be applicable from the date of delivery and acceptance.

During entire period of supply and warranty, the supplier shall ensure that call of purchaser is responded to within one week in person at the cost of the supplier.

**(d) Similar nature of supply**

# Attachment A to the Conditions of Contract

## Fraud and Corruption

*(Text in this Appendix shall not be modified)*

### 1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

### 2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and suppliers; any sub-contractors, sub-consultants, service providers or suppliers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

- a. Defines, for the purposes of this provision, the terms set forth below as follows:
  - i. "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
  - ii. "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
  - iii. "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
  - iv. "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
  - v. "obstructive practice" is:
    - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
    - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.
- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants,

sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;

- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring mis-procurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner;<sup>1</sup> (ii) to be a nominated<sup>2</sup> sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;
- e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and suppliers, and their sub-contractors, sub-consultants, service providers, suppliers, agents personnel, permit the Bank to inspect<sup>3</sup> all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

<sup>1</sup> For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

<sup>2</sup> A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its pre-qualification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

<sup>3</sup> Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
