The Government of Himachal Pradesh has received financing from the World Bank toward the cost of the Himachal Pradesh State Roads Transformation Project (HPSRTP), and intends to apply part of the proceeds for consulting services.

The consulting service ("the Services") assignment has following goals and broad objectives as under:

The main objective of the Consultancy services is to carryout feasibility study of a specified length of State Road Network and prepare detailed engineering reports, including safeguard assessment of prioritized roads and assist the Client in the procurement of civil works in compliance with the GoHP and World Bank requirements.

In this regard, HPRIDCL intends to engage a qualified eligible multi-disciplinary JV consulting Firm for preparation of Detailed Project Reports (DPR) for 221 kms (approx. aggregate length) of hilly terrain State Road Network. The scope of the project involves the design of an all-weather roads incorporating bypasses, tunnels, innovative bridges and long-span viaducts to minimize impact on existing habitation, reduce hill cutting, improve road geometry and ensure environmental and social sustainability. The provision of tunnels and Viaducts is aimed to minimizing the environmental/social impact and enhancing the riding comfort with significant reduction in travel time.

The Himachal Pradesh Road and Infrastructure Development Corporation Limited (HPRIDCL) now invite eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short-listing criteria are given in the Expression of Interest (EoI). The EoI includes the following documents: -

- (i) Section I: Instructions for submission of Expression of Interest and Guidelines for preparation of EoI.
- (ii) Section II: Eligibility and short-listing Criteria including Annexure-I to V.
- (iii) Section III. (Not attached: Can be downloaded from the website) The attention of interested Consultants is drawn to paragraphs 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017 and August 2018 ("Procurement Regulations"), setting forth the World Bank's policy on Conflict of Interest.

It would be mandatory for a national bidder to have a Joint Venture (JV) with foreign consultancy firm working in developed countries having extensive experience in tunnel and long span viaduct/bridge development. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

### Section - II

### **Short Listing Criteria**

### A. ANNUAL TURN OVER

4

(i) Annual Average turnover of last five financial years i.e. from 2019 -2020 to 2023- 2024 updated to the financial year 2023-24 shall be more than Rs. 8.0 crores for lead member of JV. This threshold for each other member of JV shall be more than Rs 5.0 crores.

For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement/updating factor corresponding to that year given in the Annexure-II.

Audited Balance Sheet, Profit & Loss account for the financial years 2019 -2020 to 2023-2024 are to be submitted.

### B. EXPERIENCE

The Consultant must have experience as follows:

- i. The experience of Detailed Design and DPR Preparation (on item rate/EPC) of road project involving road length not less than 100 Km for 2-lane carriageway or 50 Km for 4-lane/6-lane carriageway in each project for lead member of JV and for other partners it would be 80 Km or 2-lane carriageway and 40 Km for 4-lane/6-lane carriageway (for each project). Such project must have been completed within last 10 (ten) years including 2024.
- ii. The experience in preparation of feasibility and DPR documents for addressing the Environmental and Social issues within Environmental and Social Management Framework for similar 2 no. road projects completed within last 10 (ten) years including 2024.
- iii. To minimize environmental & social impact the bidder must have successfully designed at least two tunnels of minimum 500m length in mountainous or hilly terrain. Out of these, one tunnel must be more than 1000m in length and include escape tunnel provisions. The design must have been successfully implemented at site or at least 80% completed as on submission date by implementing agency. The bidder will submit the status report of client as evidence for the same.
- iv. The bidder must have experience in the design of least one innovative bridge or viaduct with a total length of at least 300m, including at least one single clear span of 70m or more in challenging environments such as deep gorges, rivers or urban settlements, utilizing advance structural techniques.
- v. Experience in externally aided projects shall be given preference.

### C. ORGANISATIONAL STRUCTURE & PERMANENT STAFFING

- (i) At least 7 years in the business of preparing Feasibility/DPRs with minimum 3 years in Feasibility/DPRs in Hill Road experience.
- (ii) Should have at least 4 nos. of permanent Key Expert

A Project would qualify as similar Project, if it meets with following:

a. Widening & Strengthening of existing roads in hilly terrain

Consultant must satisfy A, B and C for becoming eligible for short-listing.
