Subject: Consideration of the left-out cases of scholarship holders of Project Year 2013-14 (Exam Year -12), Project Year 2014-15 (Exam Year -13), Project Year 2015-16 (Exam Year -14)), Project Year 2016-17 (Exam Year -15), Project Year 2017-18 (Exam Year -16) in off-line mode till the attainment of class-XII in their respective years till 2020-21 under National Means-cum Merit Scholarship Scheme (NMMSS)

Madam/Sir

This has reference to the offline applications of the eligible students for NMMSS up to the project year 2017-18 (Exam Year 2016). In this regard, it is to be stated that during 2017-18, the applications of all the eligible students for classes- IX, X, XI and XII were invited in online mode through National Scholarship Portal (NSP) under NMMSS scheme. But due to some technical problems, all the eligible students could not register themselves on NSP.

The matter has been discussed with the MHRD, Delhi and it has been decided by the ministry that the left out cases up to the project year 2017-18 (exam. 2016) will be considered in offline mode and all the cases will be disposed by 2020-21. The exemption to consider the aforesaid left - out cases in offline mode has been given up to the year 2020-21 by the Ministry only to avoid the non-disbursement of scholarships to NMMSS scholarship holders. From The year 2020-21 onwards, no such exemption will be given in any circumstances.

Therefore, all the concerned GSSSs/GHSs Heads are requested to send the data of all the aforesaid left out eligible students in soft copy on the format attached to The Principal, SCERT, Solan Himachal Pradesh-173211as soon as possible, ensuring that the data of left out student does not include any duplication. The data of the students should be verified properly by the head of the institution.
